Dear Mr Stankovic,

I am writing to you to provide a written estimate of the charges that may be incurred by treatment at the Hammersmith Hospital for patient Ms Miljana Ristic Stankovic.

Initial Consultation and Investigations

I have listed below the initial consultation fees and costs for some of the investigations that may need to take place on the initial visit.

Initial consultation fee; £250.00

Blood tests; £31.00 up to £150.00 per tests for standard blood tests

Bone Marrow Biopsy; £685.00

Histology; £230.00

Scans; Starting at £145.00 going up to £2845.00 – depending on which ones are needed

Day case bed charge; £525.00 Overnight bed charge; £1025.00

Donor Search (undertaken by The Anthony Nolan Trust)

The donor search conducted by Anthony Nolan is free of charge, whoever should a donor be successfully sourced charges will apply to collect the cells from the donor and transport them to us. The charges will depend on the area/country the donor is found.

Matched Unrelated Donor Stem Cell Transplant; £204,050.00 Package Duration; 42 days

The package covers the transplant episode of care from the day of admission to discharge, up to the maximum stay (trim point) of 42 days. Beyond the trim point, itemized charges will apply in accordance with the Trust's agreed schedule of tariffs. If the patient is already an inpatient for chemo or investigations, they will confirm the transplant start date and the package will begin then.

Package exclusions:

 All pre-transplant costs for treatment received prior to admission for transplant including donor search.



- All post-transplant treatment which takes place after the 42 day package, even if the patient has not yet been discharged.
- ITU/CCU care.
- High-cost antifungal drugs
- Cost of any treatment required which is not in relation to the patients diagnosis or transplant treatment.
- Professional fees other than for the hematology consultants (for example professional fees for Hickman Line insertion).
- Further transplantation if required within the package timeframe.
- Private personal expenses such as telephone bills, relatives' accommodation and additional catering.

Based on the information that the treatment needed is as outline above the deposit required by the hospital would be £250,000.00.

As proposed by yourself, we would be happy to accept an initial deposit of £100,000.00 to cover the initial consultation/investigations and the donor search, however the remaining £150,000.00 would need to be deposited before the transplant can take place.
